Have you DRAFTED YOUR LEGAL Legacy ?

THERE IS NO TIME LIKE THE PRESENT to get started on drafting your Legal Legacy Documents. As with any legal document, an attorney should be involved in drafting or reviewing the document. **ONCE YOU SIGN** a legal document, your signature indicates you agree with everything it states. You always need to have an attorney review it to ensure it contains the necessary wording and covers all of your needs. Below is a checklist of the **MUST HAVES**.



WILL

A will enables you to decide what happens to your possessions after your passing.

Without a will, you have no control over what happens to your assets when you are gone.



LIVING WILL

This takes effect when you are terminally ill and unable to express your wishes about your care. It documents the type of treatment you want, but it doesn't designate someone to make decisions on your behalf.



POWER OF ATTORNEY

This legal document designates who can make legal decisions on your behalf should you become incapacitated. A Power of Attorney allows an individual you choose to make bank transactions, sign checks and make other financial decisions on your behalf.



HEALTHCARE PROXY

A Healthcare Proxy allows you to designate an individual to make decisions for you if you are unable to. It is a good idea to have both a living will and a healthcare proxy to ensure that someone you trust is in charge of your medical care.
