DOES YOUR BUSINESS NEED IN-HOUSE COUNSEL?

this process, you do have to meet several requirements, though, including the creation of articles of incorporation and filing for an Employer Identification Number (EIN) with the IRS so your business can be taxed, if your business is a corporation. If you fail to meet these requirements, your business will be operating illegally, which is why many individuals seeking to go into business prefer to let an attorney handle all the paperwork so they know everything has been done properly.

COMMERCIAL AGREEMENTS

As with the papers required to form your business, when it comes to forming commercial agreements with other parties, whether they are clients, vendors, or business partners, you do not want to leave anything out. Ensuring the contract covers every legal issue that might arise between you and the other signing party is one of your greatest defenses against the other party taking legal steps against you if they believe you are in breach of contract.
